

Regulation

This Regulation aims to establish the criteria, methods and operability of the organs of the association and members, as well as the mutual relations between members, users and institutional investors of **Architectura.Place**.

Users

All those who are not in conflict with the aims of the association, do not post content that may offend the dignity and sensitivities of the people and not violate the law of the states in which they operate and the international law, may join the association **Architectura.Place** and become part of its Social Network.

By joining provides the following services:

- Account with the personal profile by which to interact with the Internet platform of the association, evaluating, commenting and sharing content;
- Maintenance of the account and the full availability of the social network of the members of the association, with the ability to communicate, interact and establish direct links between the parties adhering in the manner that will be implemented during the formation of the Internet platform and subsequent updates.

Joining is free and is formalized with the recording of personal data, the acceptance of the terms and conditions of the association and the privacy practices, in accordance with the website's form.

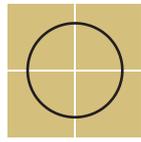
The Board of Directors, after consultation with the a special commission, has the right to withdraw in case of violations of the terms of the association, of publishing content that offend the dignity and sensitivities of the people at the discretion of the Board and in the event that the same violation of the law of the states in which they operate and the international law.

Members

All those interested to develop and prosecute the content and purpose, contributing to the reporting of the problems and the resolution of them, may apply for association to **Architectura.Place** as members.

By associating provides the following services:

- Account with the personal profile by which to interact with the Internet platform of the association, evaluating, commenting and sharing content;
- Maintenance of the account and the full availability of the social network of the members of the association, with the ability to communicate, interact and establish direct links between the parties adhering in the manner that will be implemented during the formation of the Internet platform and subsequent updates;



- Blog interrelated with the platform of the association where they can be published professional and cultural experiences, related with the content and purpose of the same Association;
- Use of the name and the registered trade mark by the association, with the ability to add in their identification documents, such as letterheads and headers in general, with the words "Member of Architectura.Place", as specified at the time of association itself.

When accepting the association request as an ordinary member, it must be paid a contribution to the association of € 300.00 (EUR three hundred point zero). The annual membership fee is established in € 100.00 (EUR hundred point zero).

Association requests are reviewed by the Board of Directors, after consultation with a special commission, following the evaluations of compatibility with the contents of the Statute.



By honorary associating provides the following services:

- Account with the personal profile by which to interact with the Internet platform of the association, evaluating, commenting and sharing content;
- Maintenance of the account and the full availability of the social network of the members of the association, with the ability to communicate, interact and establish direct links between the parties adhering in the manner that will be implemented during the formation of the Internet platform and subsequent updates;
- Blog interrelated with the platform of the association where they can be published professional and cultural experiences, related with the content and purpose of the same Association;
- Use of the name and the registered trade mark by the association, with the ability to add in their identification documents, such as letterheads and headers in general, with the words "Honorary Member of Architectura.Place", as specified at the time of association itself;
- Reference and direct representation of the association in relation to a geographical area, a cultural area or to a specific discipline area.

Also, they constitute grounds for revocation of registration, improper use of the name and logo of the Association and the failure to pay the annual membership fee.
