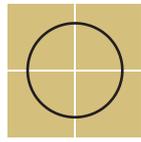

Responsibility for the contents



Privacy




